A comprehensive assessment of 9 screens was performed in November 2021, including:

- Home page
- Browse
- Register
- Login
- Film Viewing Page - Video Player
- Film Viewing Page - Make a Clip
- My Account - Account Info

- My Account - Licensed Films
- My Account - Clips/Playlists/Searches

A follow-up evaluation was made of issues discovered during the initial assessment, and completed in March 2022. This report was created upon completion of those follow-up accessibility evaluations.

Evaluation Methods Used:

- Manual assessment was performed using Chrome/NVDA on Windows 10.
- Automated tools used included the Deque aXe browser extension & Deque aXe Auditor.
