A follow-up evaluation was made of issues discovered during the initial assessment, and completed in March 2022. This report was created upon completion of those follow-up accessibility evaluations.

Evaluation Methods Used:

- Manual assessment was performed using Chrome/NVDA on Windows 10.
- Automated tools used included the Deque aXe browser extension & Deque aXe Auditor.
